- ✓ Write down the **names, addresses, telephone numbers and license numbers** of the **people** and **vehicles** involved, as well as any **witnesses**.
- ✓ Take **Pictures** of the **accident scene** and the other driver's **license**. Take as many notes as you can.
- ✓ Do **not** discuss the accident with anyone other than the police, **your** insurance company and an attorney.

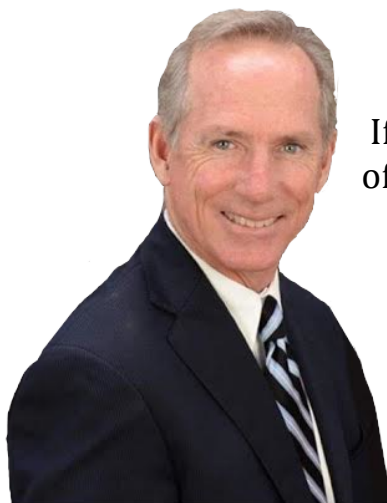
